Purpose of Report

To consider amending the 2023/24 Capital Roads Program.

Background

The current 2023/24 Capital Roads Program was adopted by Council at its Ordinary Meeting held in July 2023 as part of the 2023/24 Budget.

Since the budget was adopted a new Acting Manager of Works has commenced while the Shire recruits a new Manager of Works.

Consultation

Councillors were emailed a copy of the Acting Manager of Works' recommended changes to the 2023/24 Capital Roads Program on 9 August 2023.

The Executive Officer of the Regional Road Group has advised:

It will likely be a problem to change your 23/24 Yr Program at this point in time, given the amount of changes this program has undergone over the last few months, and the fact that we are into the 23/24 Yr.

I know that Alli advised last year after Wyalkatchem changed their program midway through the financial year, that she would not accept any changes once the final program has been endorsed – which was what occurred at the 17th July 23 SRRG Meeting.

Staff have approached Allison Hunt, the Local Government Interface Manager for the Wheatbelt Region (Northam and Narrogin) to ask if it would be possible to change the Shire's 2023/24 Regional Road Groups. At the time of writing this report no response had been received.





Statutory Environment

Local Government Act 1995, Section 6.2 - Local government to prepare annual budget

A local government is to adopt an annual budget which takes into account the contents of the plan for the future of the district made in accordance with Section 5.56.

The Shire of Trayning Council Plan 2022-2032 was adopted by Council at its Ordinary Meeting held 20 April 2022, replacing and combining the previous Strategic Community Plan and Corporate Business Plan. It was renamed the Shire of Trayning Strategic Community & Corporate Business Plan at the Ordinary Meeting of Council held 15 February 2023.

The financial implications of the proposed changes to the Capital Roads Program have not been determined.

Strategic Implications

The proposed changes to the Regional Road Group Projects and Roads to Recovery Projects are significant deviations from the adopted Long Term Financial Plan and Asset Management Plan.

Both of these plans were proposed to be reviewed following asset renewal modelling carried out after the revaluation of roads and other infrastructure. The revaluation report has yet to be completed.

Officer's Comment

The Acting Manager of Works has provided the following infomation on the proposed changes to the 2023/24 Capital Roads Program:

Kununoppin – Mukinbudin Road was to be reconstructed and a 2 coat seal put down SLK 21.26 to SLK 22.83 total 1.57 kilometres. At this stage the drainage, shoulders and seal are in good condition and need no major works. I would be looking at the seal in 4 to 5 years, during this period minor maintenance repairs are all that is required to maintain the asset.

Recommended change

Kununoppin – Mukinbudin Road Reseal SLK 21.26 to 23.83 (shire boundary) extra 1 km, widen road from 6.5m to 7m seal by using a jet-patcher and sealing this 250mm to 300mm shoulder then resealing over the top with 14mm.

Harrod Road was to be reconstructed and a 2 coat seal put down at floodway from SLK 6.1 to SLK 7.4. At this stage the floodway and seal are okay and can be maintained by general repairs by the Shire if required, eg potholes and minor drainage work when doing maintenance grading. That way we can look at doing a reseal in 24/25 from SLK 6.1 to SLK 10.00, hence if we do the shoulder widening (see below) that gives us a year to see if we have any failures before we put a 14mm seal over the 4.9 km and can action as required with the stabilisation of the Floodway area.

Recommended change

Harrod Road to have 2 m shoulders added on each side from SLK 6.1 to SLK 10.00 plus drainage and seal width to be widened from 6.5m to 7m with Jet-patcher (ready for reseal in 24/25).

Kellerberrin-Yelbeni Road gravel re-sheeting on the 8 m wide SLK 12.24 to SLK 14.8.

Recommended change

No change, possible extension see below.

Sherzinger Road Reconstruction and double seal 3.7 m wide SLK 5.41 to SLK 6.7 at this stage the seal is in good condition as well as the shoulders, maintenance grading can maintain the shoulders for some time yet, money could be spent on several gravel roads that are in need of urgent repairs/re-sheeting.

Changes to be made

More gravel sheeting on the Kellerberrin-Yelbeni Road as several sections are in need of repair due to clay content being very high and are quite dangerous with the slightest drop of rain on them.





Officer Recommendation

That:

- 1) An application be made to the Regional Road Group to amend the Shire's 2023/24 Regional Road Group projects to the following:
 - a. Kununoppin-Mukinbudin Road reseal SLK 21.26 to 23.83, widen road from 6.5m to 7m seal by using a jet-patcher and sealing this 250 mm to 300 mm shoulder then resealing over the top with 14mm
 - b. Harrod Road add 2 m shoulders on each side from SLK 6.1 to SLK 10.00 plus drainage and seal width to be widened from 6.5m to 7m with Jetpatcher (ready for reseal in 24/25)
- 2) Should the application to amend the Shire's 2023/24 Regional Road Group projects be successful, prepare an agenda item for the September 2023 Ordinary Meeting of Council to replace the Shire of Trayning's Five Year Regional Road Group Program and amend the 2023/24 Budget accordingly.
